ORDER

The Commissioner for Entrance Examinations conducted the Second Phase Allotment as per the Schedule of Ministry of Health and Family Welfare, Government of India, on 26/04/2018 without waiting for the reversion of the unfilled seats in the second round of counseling of the All India Quota. In the circumstances, the candidates who would otherwise have got admission to a specialty of their choice in the surrendered seats will be denied option to avail themselves of such seats which will be an injustice to the meritorious students. In order to avoid the above situation, Government issued G O read as 4th paper above. Now as per the judgment read above, the Hon'ble Supreme Court ordered that the States/ Deemed/ Central Institutions who have completed the Second round of Counseling without waiting for the reversion of the unfilled seats in the second round of counseling of the All India Quota to conduct the Second round of Counseling again. Hence as per the letter read above the Commissioner for Entrance Examinations has requested to cancel the G O read as 4th paper above

Government have examined the matter in detail and are pleased to cancel the G O read as 4th paper above. The following guidelines are also issued to the Commissioner for Entrance Examinations for the smooth conduct of the Mop Up round

- 1) The Mop Up round will be based on the Revised Rank List published vide Notification dated 06/05/2018.
- 2)Those Candidates who have joined P G Course in State Quota in Second Phase Allotment shall not be eligible to participate in the Mop Up Round.

- 3)Those Candidates who have joined P G Course in State Quota on exit, after being allotted to the seats in the second round will have to forfeit 10% of the annual fee if they do not join the course ie the exit shall be allowed on forfeiture of 10% of the total annual fee during the second round and if they have joined the course they will not be eligible for further counseling. In case the applicant retains the seats in the first allotment and he/she is not allotted any seats in the second allotment then this allotment in the first allotment will be considered as equivalent to the seat allotted in second round and he will have to forfeit 10% of annual fee, if he decides to quit before the last date of surrender of seat already allotted.
- 4) Candidates (except SC/ST/OEC/Children of Fishermen) getting fresh admission to any Government Medical College through Mop Up Round shall have to produce a Demand Draft for Rs. 50,000/- for Degree Courses and Rs. 45,000/- for Diploma Courses drawn in favour of Commissioner for Entrance Examinations, payable at Thiruvananthapuram at the time of allotment . A candidate getting fresh allotment in Private Self Financing Medical Colleges for Degree/ Diploma Courses shall have to remit Rs. 5,00,000 by way of Demand Draft drawn in favour of Commissioner for Entrance Examinations, payable at Thiruvananthapuram. Remaining fees shall have to be remitted in the allotted college.
