The commissioner for Entrance examination through communication dated 27.11.2021 has brought to the notice of the Committee that the CEE has received considerable number of request relating to visa validity period and also attestation of employment certificate and requested to provide a clarification whether the relaxation allowed during the Academic year 2020-21 may be made applicable to this academic year 2021-22 also.

The Committee has gone through the communication received from the CEE and found that the clarification sought for by the CEE is found appropriate considering the prevailing pandemic situation. Therefore the Committee hereby clarify that the relaxation allowed during 2020-21 can be made applicable to this academic year also and is made applicable. The relevation allowed during the academic 2020-21 is reproduced here under:-

"In view of the pandemic situation, many of the embassy/ consulate have not regular/normal functioning and the aspirants have expressed their inability to produce the embassy related/attested documents. Hence, the aspirants are given a month time from the date of allotment by CEE or two days prior to the 2nd allotment by the CEE, whichever is earlier to produce the above documents from the embassy/ consulate authorities. The aspirants shall produce a sworn affidavit obtained from the sponsor in this regard attested by the Notary public, as per the rules and regulations prevailing in the country."

"In the case of validity of visa has expired, the copy of the document, regarding online acknowledgment seeking extension of visa shall also be considered"

The relaxations are only for this academic year 2021-22 considering the prevailing pandemic situation and this shall not be a precedent for the next academic year.
