**FIFTH PHASE ALLOTMENT TO MEDICAL & ALLIED COURSES**  
**EXCEPT MBBS/BDS COURSES PUBLISHED**

The fifth and final phase of allotment to Medical & Allied Courses except MBBS/BDS Courses in Kerala -2015 is published herewith on the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) . Those students who had confirmed their options online within the stipulated time alone are considered for the fifth phase of allotment to Medical & Allied Courses.

The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available on the home page of the candidate. The candidates should take a printout of the allotment memo pertaining to the fifth phase of allotment to Medical & Allied courses and produce it before the authorities of State Bank of Travancore (SBT) for payment of fee/balance fee. The list of designated branches of SBT is available on the website.

Those candidates who receive an allotment afresh should remit the fees to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo at any of the designated branches of State Bank of Travancore on any date from 17.10.2015 to 20.10.2015 and should join the course/college allotted before 5 pm on 20.10.2015.

The candidates who get a change in allotment than that of the previous allotment should pay the balance fee, if applicable, in a designated branch of SBT on any date from 17.10.2015 to 20.10.2015 and should join the course/college allotted as per the allotment memo before 5 pm on 20.10.2015.

This is the last phase of allotment to Medical & Allied Courses. Hence the candidates who get allotments to such colleges should invariably join the allotted colleges. Otherwise they are liable to pay the Liquidated damages as envisaged under Clause 12.2.4 of the Prospectus for KEAM-2015.

Important: The Allotment to Mannam Ayurveda Co-operative Medical College, Pandalam, Ahalia Ayurveda Medical College, Palakkad, Pankaja Kasthuri Ayurveda College, Kattakkada, Thiruvananthapuram, Parassinikadavu Ayurveda Medical College, Parassinikkadavu, Kannur and Santhigiri Ayurveda Medical College, Palakkad, P N Panicker Sauhrida Ayurveda Medical College, Kanhangad, Vishnu Ayurveda College, Shornur, Palakkad will be subject to the result of the writ petitions pending before the Hon'ble High Court of Kerala.

Note: Candidates admitted in Govt./ Govt. Controlled Self Financing Engineering Colleges can accept the new allotment to Medical & Allied Course only after paying the liquidated damages as per clause 12.2.4 of the Prospectus-2015 and orders issued by the Government.

Candidates admitted in Private Self Financing Engineering Colleges under Kerala Catholic Engineering College Managements Association can accept the new allotment to Medical & Allied Course subject to the conditions in GO(MS) No. 252/2014/H.Edn. Dated: 07.06.2014.

The Candidates admitted in other Private Self Financing Engineering/Architecture Colleges who are allotted to Medical & Allied courses through KEAM 2015 need not pay the Liquidated Damages as per GO(MS) No.372/2015/H.Edn. Dated: 03.07.2015 and GO(MS) No.378/2015/H.Edn. Dated: 03.07.2015 for getting Transfer Certificate and other Documents. But the fees remitted for the year shall not be refunded.
