KEAM 2021 ADMISSION TO MBBS/BDS COURSES SECOND PHASE CENTRALISED ALLOTMENT PUBLISHED

The second phase of allotment to MBBS/BDS Courses-2021 is published in the website of Commissioner for Entrance Examinations **www.cee.kerala.gov.in**. The allotment is based on the online options filled by the candidates up to 10 AM on 11.03.2022 through the above website. Those Candidates who got admitted in All India Quota MBBS/BDS seats have not been considered for this phase of allotment to MBBS/BDS courses.

The details of allotment is available in the Home page of candidates. The allotted candidates should take printout of the Allotment Memo. The details of allotment of candidates such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available in the Home Page of candidates as well as in the Allotment Memo. Candidates can take printout of the Allotment Memo and can pay the fee prescribed in the Allotment Memo from 15.03.2022, 4 PM.

Candidates who receive an allotment afresh should remit the fees to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo at any of the Head Post Offices in Kerala or by way of Online Payment. The list of Post Offices having facility for fee payment is available in the website. After paying the fee/balance fee (if applicable), candidates should join to the college/course concerned from 16.03.2022 to 19.03.2022, 2 PM with all documents mentioned in Prospectus clause 11.7.1. Those candidates who do not join the course/college allotted within the stipulated time will lose their present allotment.

Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sri Chitra Home, Juvenile Home, Nirbhaya Home should pay Rs. 1000/- as token fee to the Commissioner for Entrance Examinations. However if they are allotted seat under Minority/NRI quota seats in Self-financing Medical/Dental colleges they will have to remit the token fee as shown in the allotment memo prescribed to CEE and they

will not be eligible for fee concession.

Candidates who have an allotment can download the 'Data Sheet' containing the basic details of the candidates by clicking the menu item 'Data Sheet' available in the Home Page of the candidate. The printout of this Data Sheet is to be produced before the college authorities at the time of admission.

Allotment to vacant seats to MBBS/BDS courses that may arise after Second Phase of centralized allotment shall be filled through Online Mop up Counselling to be conducted by the Commissioner for Entrance Examinations. In Mop up Counselling as per vacancy exists, college transfer will be permitted, from a Government College to another Government College and from a Self-Financing College to another Self Financing College, according to the options registered by the candidates afresh. Detailed notification of Mop up Counselling will be published later.
