**NOTIFICATION**

**ALLOTMENT/ADMISSION TO MEDICAL COURSES (KEAM-2021)**

**ATTENTION TO NRI CANDIDATES**

In view of the prevailing Covid pandemic situation in the Country, Admission Supervisory Committee had issued some relaxations for attested document from Consulate /Embassy for admission to NRI quota seat in Medical courses through KEAM during the academic year 2020-21. Considering the present situation, the same relaxations are allowed by the Admission supervisory committee during the academic year 2021-22 also. As per the relaxation issued by the Admission Supervisory committee, in the absence of attested copies from the Embassy/Consulate, the candidate has to submit a Sworn Affidavit obtained from the sponsor attested by the Notary Public (as per the rules and regulations prevailing the country) stating that the attested copies from the Embassy/Consulate will be produced within one month from the date of allotment or two days prior to the second allotment by Commissioner for Entrance Examinations, whichever is earlier. These candidates will be allowed NRI category on a provisional basis. Further, if the validity of visa has expired, the copy of online acknowledgement slip seeking extension of visa shall also be considered for allowing provisional NRI category. In both the above cases, if the candidate doesn't submit attested copies from the Embassy/Consulate or the new visa within the prescribed time, provisionally allowed NRI category and the admission, if any, received under NRI category will stand cancelled. The directives issued by the Admission supervisory committee for the relaxation of attested certificates from Embassy/Consulate and the format of affidavit to be submitted by the sponsor are included as annexure.

As per the revised directions issued by the Admission Supervisory Committee the NRI documents submitted by the candidates have been re-verified and memos are issued to candidates with issues with documents. Candidates who have submitted application under NRI quota seats for Medical courses should check the candidate portal and clear the memo, if any, related to the revised directives issued by the Admission Supervisory Committee. Candidates can rectify the defects in connection with the attested certificates for Embassy/Consulate as per the new directions from Admission supervisory Committee by uploading the affidavit or documents from **01.12.2021 to 10.12.2021, 5.00 pm.**

Candidates can view their profile page through the link '**KEAM 2021-Candidate Portal**' provided in the website **www.cee.kerala.gov.in** by giving their Application Number and

Password. Those candidates, who have any defects in their NRI Claim can view their defects by clicking the menu item 'Memo Details' provided in the Profile page. Candidates can rectify their defects by uploading the relevant documents within time. Those candidate who do not clear memo within time will not be considered for allotment under NRI quota for Medical courses. The time for rectification of defects in NRI category will not be extended at any instance.
