Eligibility for admission:

- i. Nativity : Applicant should be a citizen of India of Kerala origin.
- ii. Age:The candidates otherwise eligible for admission should not be more than 45 years as on 01.01.2022.subject to relaxation to a maximum of five years in the case of SC/ST, Rural Service Candidate and to Teachers of Homoeopathic Medical Colleges
- iii. Qualifying Criteria: All candidates including Service quota candidates seeking admission to MD Homoeopathy-2021 in the state of Kerala must qualify the AIAPGET- 2021 and should figure in the rank list prepared by the Commissioner for Entrance Examinations, Kerala. The minimum eligibility mark in the entrance test shall be 50th percentile in the case of general category and that of SC/ST/SEBC category shall be 40th percentile. In respect of candidates in persons with disability category, the minimum mark shall be at 45th percentile for general category and 40th percentile for SC/ST/SEBC category.

iv. Academic Qualifications

Candidates who have passed the BHMS Degree (Direct/Graded) or its equivalent, declared there to, by the Central Council of Homoeopathy/National Commission for Homeopathy. Candidates who have completed one year of internship before the date of Counselling for allotment alone are eligible for admission. The admission of the candidate to the concerned college/course shall be subject to fulfilling of above mentioned eligibility criteria.

Mode of selection:

The Selection of the candidates (including Service quota) shall be made from the rank list prepared by the Commissioner for Entrance Examinations, Kerala on the basis of the Qualifying marks in All India level common Entrance test namely AYUSH National Post Graduate Entrance Test (AIAPGET-2021).

Submission of Applications and Application Fee

Degree Courses in Homoeo (MD Homoeo) can apply Online from **25-01-2022** onwards through the website **www.cee.kerala.gov.in** of the Commissioner for Entrance Examinations by entering required AIAPGET 2021 details and then the candidate should remit the required fee by way of online payment or by way of e-chalan available during the submission of online application. Payment through e-chalan can be made in cash at the Head post offices/Sub Post Offices in Kerala. After remitting the required application feethe candidate shall upload photo and signature and all necessary certificates /documents.

Application fee once remitted will not be refunded. Service quota candidates including Rural Service should send their Application by taking printout of the application acknowledgement page along with NOC (No Objection Certificate) and all necessary certificates to the Principal and Controlling Officer, Government Homoeopathic Medical College, Iranimuttom, Thiruvananthapuram, Pin 695009 before 28.01.2021. Rural Service Candidate should attach Service Certificate from the Director of Homoeopathy along with the printout of the application acknowledgement page.

Service candidates need not send their documents to Office of the Commissioner for Entrance Examinations.

Last date of Application :

All candidates seeking admission to the course should submit the online application along with uploaded Certificates/Documents before 5 pm of **28-01-2022**. Defective and incomplete applications will be summarily rejected. No correspondence will be undertaken in this regard.Candidates will be allowed, neither to include any information in the application form nor to submit any certificates/documents claiming reservation or any benefits, after the submission of the application.

There is no need to send the printout of the application or any documents to the Commissioner for Entrance Examinations.

OPTION REGISTRATION FOR THE CENTRALIZED ALLOTMENT PROCESS

The selection and allotment of seats including those of In-service candidates will be made by the Commissioner for Entrance Examinations through the Centralized Allotment Process (CAP). In order to participate in the first phase of the centralized process (CAP) to be conducted by the Commissioner for Entrance Examinations, candidates should register options online as part of the online application process. The option registration facility will be open from **25.01.2022**. Candidates can submit options by clicking the menu item '**Option Registration**' available in the home page. The list of colleges/courses to which Commissioner for Entrance Examinations makes allotments will be available in the option

registration page. Candidate can give options as per their priority of the course-college-quota combinations in the option list. A candidate need to only give options to a course-college-quota combination, if he/she is sure to join the course and college under the chosen quota, if allotted. Based on the options filed by the candidates within the stipulated time the first phase allotment will be prepared. Detailed notification in this regard will be published later.

The approved prospectus for admission to PG Homoeo Degree Courses will be published in the website soon.

- The nativity/community/category claims made by the candidates in the online application form will be rejected, if the required documents are not uploaded to the online application within the stipulated time.
- As the allotment to any category or quota seat which a candidate is not eligible for will result in the loss of not only the allotted seat but also all the lower options and any other options which require that category or quota eligibility as a prerequisite, candidates must exercise utmost care while choosing the eligible category claim in the online application. So candidates are advised not to make any category or quota claim in their online application which they would not be able to substantiate with the prescribed supporting documents within the stipulated time limit.
- Never register options to any course or college or quota which the candidate would not like to join if allotted.
