# ADMISSION TO P G MEDICAL (DEGREE / DIPLOMA) COURSES, KERALA-2018 MOP-UP COUNSELING TO VACANT SEATS

A Mop-Up Counseling to fill up the vacant seats in P G Medical courses - 2018 in Government/Self Financing Medical colleges will be conducted at 9.30 am on 07/05/2018 and 08/05/2018/ at the Old Auditorium inside the Government Medical College campus, Thiruvananthapuram.

After including the newly registered candidates as per notification of this office even No. dated 28/04/2018, a newly Revised Kerala State Rank list will be prepared by Commissioner for Entrance Examinations and will be published on 05/05/2018. Candidates included in the newly Revised Kerala State Rank list alone will be eligible for participating in the Mop-Up Round Counseling process. After the publication of the newly Revised Kerala State Rank list, all candidates in the said rank list can register and download a Mop-Up Round Slip from the above portal. The Mop-Up Round Slip is mandatory for a candidate to participate in the Mop-Up Round Counseling process.

### **Guidelines for Mop-Up Round Counseling**

- 1. The Mop-Up Round will be based on the newly Revised Kerala State Rank list to be published on 05/05/2018.
- 2. The Mop-Up Round will be manual and as per the provisions contained in clause 10.1.18 of the prospectus for admission to PG Medical courses 2018. Those who are holding All India Quota seats will not be entitled to attend the Mop-Up Round Counseling process.
- 3. Candidates who have obtained admission in Government merit seats for a course in any of the Government Medical colleges shall not be eligible to participate in the Mop-Up counseling for the same course in the same subject in other Government Medical Colleges, but a candidate who have obtained admission for Diploma course shall be eligible for admission for a Degree course in the same/other subject of their higher course options through Mop-up round. Similarly candidates who have obtained admission in a course in any of the Self Financing Medical colleges shall not be eligible to participate in the Mop-Up round Counseling for the same subject in other Self Financing Medical colleges. However, a candidate who got admission in Government merit seat of a Self-financing Medical College shall be permitted to take admission in the same/other subject in a Government Medical College through Mop-Up Round Counseling.
- 4. Transfer from the NRI quota seats to Management/Minority or General Quota seats and vice versa are permitted.
- 5. Candidates (except SC/ST/OEC/ Children of Fishermen ) getting fresh admission to any Government Medical college /Self-financing Medical College through Mop-Up Round shall have to produce a **Demand Draft for Rs. 50,000 drawn in favour of Commissioner for Entrance Examinations, payable at Thiruvananthapuram** at the time of allotment. Remaining fee shall have to be remitted in the allotted college.
- 6. For an SC/ST/OEC/Children of Fishermen, candidate allotted to a Government Medical College or Government seats in Private Self Financing Medical Colleges (Except Management, NRI/ Minority Community seats), the token amount to be paid at the venue of allotment will be Rs.1000/- (Rupees One Thousand only). However a candidate who has already paid tuition fees to the CEE during the first or second round of allotment need to pay only the balance amount, if any, during this Mop-Up Round Counseling.

7. All vacant seats reported by the colleges concerned/DME at 5.30 pm on 03/05/2018 due to non-joining / issue of TC will be included at the Mop-Up Round. Vacancies reported on All India quota seats and the vacancies created at the time of Mop-Up Round will also be filled up then and there itself according to merit and eligibility. Mere surrender/Exchange of seat in the Mop-Up Round will not be allowed.

# Documents to be produced at the time of Mop-Up Round Counseling

- 1. Mop-Up Round slip
- 2. NEET-PG 2018 score sheet
- 3. Originals of all the Uploaded documents.
- 4. Transfer Certificate and Conduct Certificate.
- 5. Admit card issued by the National Board of Examination, New Delhi
- 6. Document to prove date of birth
- 7. Pass/Degree certificate in the qualifying examination.(MBBS Degree)
- 8. Permanent Registration Certificate from the T.C Medical Council.
- 9. CRRI Certificate.
- 10. Certificate of Eligibility/Equivalency certificate from KUHS for candidates who have passed the qualifying examination (MBBS Degree) from outside Kerala.

#### NOTE:

- a) Candidate who is holding any seat allotted during the first or second round of allotment conducted by the CEE need to submit the NEET-PG 2018 score sheet and Mop-Up Round slip only.
- b) The candidates who are allotted with a seat in the Mop-Up Round and who discontinues the course on any reason after this admission shall be liable to pay the liquidated damages as per Clause 12-2 of the prospectus for admission to PG Medical Courses 2018.
- c) The vacant seats in Government/ Private Self Financing Medical colleges after the second round of counseling will be published on the website on 06/05/2018.
