# CENTRALISED ALLOTMENT TO PROFESSIONAL DEGREE COURSES-2021 FIRST PHASE ALLOTMENT TO ENGINEERING/ARCHITECTURE/ PHARMACY COURSES PUBLISHED & ACTIVITES RELATED TO SECOND PHASE ALLOTMENT STARTED

The first phase allotment to Engineering/ Architecture/Pharmacy courses in the State for the year 2021 is published on the website <a href="www.cee.kerala.gov.in">www.cee.kerala.gov.in</a>. The allotment is based on the online options filed by the candidates from 04.10.2021 to 10.10.2021 03.00 p.m. through the above website. Allotment to seats under Sports Quota and Persons with disabilities is not included in this phase.

#### FIRST PHASE ALLOTMENT

The details of allotment will be available on the home page of the candidate. The candidates should take a printout of the allotment memo, which shows the details such as Name, Roll Number, allotted course, allotted college, category of allotment, details of fee to be paid etc.

Those candidates who have got an allotment shall have to remit the fee to be paid to the Commissioner for Entrance Examinations as specified in the first phase allotment memo at any of the Head Post Offices in Kerala or by way of Online Payment from 12.10.2021 to 16.10.2021, 5.00 pm in order to accept the allotment. The list of Post Offices is available in the website. Those candidates who do not remit the fee on or before the date prescribed for the same will lose their allotment as well as all the existing higher options in the stream to which the allotment belongs. The options once lost will not be available in the subsequent phases.

In the first phase allotment, the students allotted to Engineering/Architecture/ Pharmacy courses need not physically join the Colleges.

#### Note:

1. In the absence of University affiliation orders, three Pharmacy colleges namely MGM Silver Jubilee College of Pharmacy, Kilimanoor, Thiruvananthapuram (MGK), Department of Pharmaceutical Sciences, Cheruvandoor, Ettumanoor, Kottayam (DPB), Department of Pharmaceutical Sciences, Puthupally, Kottayam (RIB) and one Architecture College namely Talent Institute of Architecture Mudur, Edappal, Malappuram (TIR) are not included in the first phase allotment. Courses which are

- not included in the first phase allotment due to lack of university affiliation orders or for want of Government NOC will be included in the subsequent phases of allotment on receipt of required orders.
- 2. All candidates (except SC/ST/OEC candidates) who have got an allotment in Government Engineering Colleges under Directorate of Technical Education shall also have to remit Rs. 1000/- (Caution deposit) along with the tuition fee. For SC/ST/OEC candidates the token fee remitted will be adjusted in the Caution deposit.

### **ACTIVITIES RELATED TO SECOND PHASE OF ALLOTMENT**

<u>Step 1</u>: Candidates who got allotment and remitted the required fee and candidates who have not got any allotment in the first phase shall have to make online option confirmation if they want their higher order options in Engineering/Architecture/Pharmacy courses are to be considered in the second phase of allotment. For this, candidates shall have to log into their Home page and confirm their options by clicking the 'confirm' button available therein.

Step 2: After Online Option Confirmation, the candidates can re-arrange their higher order options or delete the unwanted options and also register fresh options to the newly added Courses/Colleges, if any from 12.10.2021 to 17.10.2021, 2.00 PM, through the website <a href="www.cee.kerala.gov.in">www.cee.kerala.gov.in</a>. Those who do not confirm their options online will not be considered for the second phase allotment and also their higher order options in Engineering/Architecture/ Pharmacy streams will not be available in the subsequent phases. If the candidate do not confirm his/her options the existing allotment shall be retained as per the first phase allotment. Online Option Confirmation is mandatory for being considered in the second phase of allotment for both candidates allotted with a course in the first phase and those who have not received any allotment in the first phase.

Those candidates who do not remit the fee on or before the date prescribed for the same will lose their allotment as well as all the existing higher options in the stream to which the allotment belongs irrespective of the Option Confirmation Status.

<u>Step 3</u>: On the basis of options received up to 2.00 PM on 17.10.2021, the second phase allotment to Engineering, Architecture and Pharmacy courses will be published on 19.10.2021. Candidates who receive allotment in the second phase shall have to take a printout of their second phase allotment memo and remit the fee/balance fee (if any) payable at any of the Head Post Offices in Kerala or by way of Online Payment on any date from 20.10.2021 to 25.10.2021, 4.00 pm. After remitting the fee/balance fee, the candidates should join the course/college allotted before 4.00 pm on 25.10.2021.

25.10.2021, 5.00 PM	All the college authorities should approve and submit the list of admitted candidates through Online Admission Management System (OAMS).
