## **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

Clause (a) of sub-section (1) of section 8 of the Kerala Medical Education (Regulation and Control of Admission to Private Medical Educational Institutions) Act, 2017 (15 of 2017) provides that the fee fixed by Admission and Fee Regulatory Committee shall be valid for such

period as may be notified by the Government. The Hon'ble High Court in its order dated 2-11-2017 in WP(C) No. 30032 of 2017 (D) and connected cases directed the Government to notify the fee fixed by AFRC. In view of the proposed take over of Academy of Medical Sciences, Government requested the Committee to revise the fee applicable for PG medical admission for the year 2018-19. Accordingly, the Admission and Fee Regulatory Committee revised the fee applicable for admission to PG medical courses in respect Academy of Medical Sciences for the academic year 2018-19. Hence this notification.

This notification is intended to achieve the above object.
