ORDER

As per Clause 10-1.18 of the prospectus for admission to Medical PG Degree/Diploma Courses 2018-19 a candidate who figures in the rank list/category list prepared but not joined under All India Quota seats alone is entitled to attend the Mop up round process. In the Government order read as 2nd paper above, forfeiture of 10 % of annual fee was insisted for exit after being allotted to seats in the 2nd round

2. As per the order read as 3rd paper above, the Hon'ble Apex court stayed the reversion of vacant PG (MD/MS/Diploma & MDS) seats under 50% All India Quota by the Central Government to State Government/s until further orders.

Meanwhile, the Commissioner for Entrance Examinations has completed second round allotment to PG courses as per the schedule. This would mean that students who would otherwise have got admission to a specialty of their choice in the surrendered seats will be denied option to avail themselves of such seats. This would amount to gross injustice being meted out to meritorious students.

- 3. In order to avoid the above situation ,Government hereby waive the condition of forfeiture of annual fee stipulated in the Government order read as 2nd paper above and permission is hereby granted to all students admitted in the State Quota (1st and 2nd round of allotment) to appear in the mop up allotment. However, this benefit will not be allowed to students who got allotment under All India Quota.
- 4. All other conditions in the prospectus regarding allotment in the mop -up round shall apply as such.
