# NOTIFICATION ADMISSION TO BDS COURSES-2021 SPECIAL VACANCY FILLING ALLOTMENT

The vacancies existing in BDS course in Government Dental colleges and Self Financing Dental colleges after the Mop Up allotment for the academic year 2021-22 shall be filled up through Special Vacancy Filling Allotment. Those candidates who are included in the State Medical rank list published by the Commissioner for Entrance Examinations, subject to satisfying the eligibility conditions specified herein, can register options afresh to the Special Vacancy Filling allotment from 06.05.2022 to 08.05.2022, 10.00 AM.

### **Guidelines to the Special Vacancy Filling Allotment**

- 1. Special Vacancy Filling Allotment is conducted only to the vacancies existing in BDS course. College transfer will not be allowed in this phase of allotment.
- 2. Those candidates who were allotted in MBBS/BDS course through All India Counselling will not be considered for Special Vacancy Filling Allotment.
- 3. Those candidates who were admitted in Medical and Medical allied courses through previous allotments conducted by Commissioner for Entrance Examinations and those candidates who were allotted a seat in a Medical or Medical Allied course through the respective Mop-up allotments or a subsequent Stray vacancy filling allotment will not be considered for this Special Vacancy Filling allotment.

## Special Vacancy Filling Allotment Registration fee

1. Those candidates who register options only to Govt BDS course shall have to pay an amount of Rs.10,000/-(Rupees Ten thousand only) and those candidates who register options to Self Financing BDS courses shall have to pay an amount of Rs.1,00,000/- (Rs. One lakh only) as Registration fee to Commissioner for Entrance Examinations. Those candidates who have already paid registration fee for MBBS/BDS Mop

- up allotment and did not get any allotment, need not pay the registration fee in Special Vacancy Filling allotment.
- 2. Candidates allotted under SC/ST/OEC/Children of Registered Fishermen category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sree Chitra Home, Juvenile Home, Nirbhaya Home should pay Rs. 5000/- (Rupees Five Thousand Only) as Registration fee to the Commissioner for Entrance Examinations. However, if they give options in Minority/NRI quota seats in Self-financing Dental colleges, they will have to remit the Registration fee as mentioned in the previous para.
- 3. Mop-up registration fee paid for allotment to other Medical (Except MBBS/BDS) and Medical allied courses will not be carried forward for this Special Vacancy Filling Allotment.
- 4. The registration fee applicable to a candidate will depend on the details entered by the candidate in the Special Vacancy Filling Allotment Registration Page available in the Candidate Portal in the website www.cee.kerala.gov.in. Candidates can register options to Special Vacancy Filling Allotment only after paying the applicable Registration fee to the Commissioner for Entrance Examinations. Candidates should be very careful, while providing information to fix the Registration fee as it will determine the options available for registration.
- 5. The registration fee of those candidates, who get an allotment through Special Vacancy Filling Allotment will be carried over to Tuition Fee of course allotted. The Registration Fee of those candidates, who will not get any allotment will be refunded.
- 6. Candidates should give options only to the Colleges where they want to study if they get an allotment.
- 7. The allotment received through Special Vacancy Filling Allotment cannot be changed later.
- 8. The Registration Fee of those candidates who do not join within the stipulated time after getting an allotment and those candidates who quit seats after taking admission through Special Vacancy Filling Allotment, will be considered as penalty and will not be refunded. Such students will also be penalized as per Prospectus clause 12.2.4(c)(ii).
