ADMISSSION TO THREE YEAR LLB COURSES 2022 FIRST PHASE ALLOTMENT PUBLISHED

The First Phase of Centralized Allotment (CAP) for admission to Three year LL.B Course in 4 Government Law Colleges and 9 Private Self-financing Law Colleges of the State for the year 2022-23 is published in the website www.cee.kerala.gov.in. The allotment is based on the rank in the rank list of Three Year LLB course published by the Commissioner for Entrance Examinations and online options registered by candidates from 28.10.2022 to 04.11.2022,3.00 PM. Provisional list for first phase allotment was published on 07.11.2022 in the website of the Commissioner for Entrance Examinations. Final allotment to the course has been published after addressing complaints on provisional allotment list. The online options registered by candidates whose results have been withheld have not been considered for allotment.

Candidates can access their homepage by entering their application number, and password in the **'Three Year <u>LLB 2022-Candidate Portal</u>'** provided in the website. Then by clicking the menu item **'Allotment Result'** candidates can download their allotment memo. The details such as candidate's name, roll number, allotment details, tuition fees etc. are available in the allotment memo. The candidate shall take a print out of the allotment memo. Candidates can log into their Home Page and then click the Menu Item **'Data Sheet'** for downloading the Data Sheet.

Candidates who receive allotment should report for admission to the Principal of the allotted colleges on any date from **10.11.2022** to **14.11.2022**, **3.00** PM along with the allotment memo and original documents specified in Clause 18 of the Prospectus. They should remit the complete fees as per Government orders in the allotted college at the time of admission. Candidates will be liable to pay at the revised rate as and when the fee for the academic year 2022-23 in the Government Law colleges are revised. All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) on **14.11.2022**, **5.00PM**.

Candidates belonging to SC/ST/OEC/Communities eligible for Educational concessions as is given to OEC/Candidate eligible for Fee concession as per G.O. (Ms)NO.25/2005/SCSTDD. Dated.20.06.2005/Children of Fisherman/Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

Candidates who do not join the college on the specified dates, will lose their present allotment and also the higher order options. Their existing options will not be considered for further allotments, if any. The details regarding further allotments(if any) will be notified later.

Note:

- Candidates who have claimed SC/ST reservation and whose caste status is under scrutiny by KIRTADS or Government have been provisionally considered for allotment. The allotment/admission, if any, of such candidates shall be purely provisional and subject to final verification of their caste status.
- Allotment to Three Year LLB course (additional batch) in Sree Narayana Law college,Poothotta, Ernakulam will be subject to the final judgement in writ petition (c)No.34711 of 2022.
- Additional seats which are not included in the first phase of allotment due to lack of orders from Bar Council Of India, University, Government will be included in the subsequent phases on receipt of required orders.
