THIRD PHASE ALLOTMENT TO ENGINEERING/ ARCHITECTURE/ PHARMACY COURSES PUBLISHED

The Third phase allotment to Engineering/ Architecture/ Pharmacy Courses 2021 is published in the website www.cee.kerala.gov.in. This is the last phase of allotment to Self Financing Engineering/Architecture/ Pharmacy colleges conducted by Commissioner for Entrance Examinations.

Those candidates who have got an allotment in this phase should join to the colleges concerned from 10.11.2021 to 15.11.2021, 4.00 pm. The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available on the home page of the candidate as well as in the Allotment Memo. The candidates should take a printout of the allotment memo from the Home Page.

Candidates who receive an allotment in this phase should remit the fees to be paid to the Commissioner for Entrance Examinations (if applicable) as specified in the allotment memo at any of the Head Post Offices in Kerala or by way of Online Payment on any date from 10.11.2021 to 15.11.2021 and should join the course/college allotted before 4 pm on 15.11.2021. The list of Post Offices having facility for fee payment is available in the website.

Those candidates who do not remit the fee/balance fee (if applicable) and who do not join the course/college allotted within the stipulated time will lose their allotment.

Candidates who have got an allotment can download the 'Data Sheet' containing the basic details of the candidates by clicking the menu item 'Data Sheet' available in the home page of the candidate. The printout of this Data Sheet, this phase allotment memo, and other documents (as per Prospectus clause 11.7.1) are to be produced before the college authorities at the time of admission.

Important:

- 1) For the candidates who get an allotment through this phase to the Private Self Financing Engineering/Pharmacy colleges and who do not join colleges before the stipulated time, the conditions as per prospectus clause 12.2.4 (c)(i) shall be applicable for filing/retaining unnecessary options.
- 2) For the candidates who get an allotment through this phase to the Private Self Financing Architecture colleges and who do not join colleges before the stipulated time the conditions as per prospectus clause 12.2.4 (c)(ii) shall be applicable for filing/retaining unnecessary options.

The detailed schedule showing the date and time for joining to Engineering/Architecture/pharmacy courses is published in the website www.cee.kerala.gov.in. Candidates are required to visit the website of the colleges concerned for instructions, if any, with regard to the admission.

The notifications regarding further allotment to Government/Government Aided Engineering/Architecture/Pharmacy courses conducted by the Commissioner for Entrance Examinations will be published in the website later.
