**ADMISSION TO MBBS/BDS COURSES**  
**FIRST PHASE CENTRALISED ALLOTMENT PUBLISHED**

The first phase of centralised allotment to MBBS/BDS courses to the State quota seats in Government Medical/Dental colleges and Private Self Financing Medical/Dental Colleges in the state of Kerala for the academic year 2021-22 is published in the website of Commissioner for Entrance Examinations [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). As the affiliation from Dental Council of India has not yet been received, the allotment to Sree Sankara Dental College, Akathumuri, Varkala is not included in this phase of allotment.

The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available in the Allotment Memo.

Candidates should take a printout of the allotment memo from the Home Page. The allotted candidates can download the 'Data Sheet' containing the basic details of the candidates from 03.02.2022, by clicking the menu item '**Data Sheet**' available in the home page of the candidates. The printout of this Data Sheet, allotment memo and the documents as per clause 11.7.1 should be produced before the college authorities at the time of admission.

Candidates allotted under SC/ST/OEC category, Children of Fisherman, and those communities eligible for educational concession as is given to OEC having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sreechitra home, Juvenile home, Nirbhaya home are eligible for Government approved fee concession. However they should remit Rs.1000/- as token deposit to the Commissioner for Entrance Examinations. However if they are allotted seats under Minority/NRI quota in Self-financing Medical/Dental colleges they will have to remit the fee shown in the allotment memo and they will not be eligible for any fee concession.

Candidates who have received an allotment should remit the fees to be

paid to the Commissioner for Entrance Examinations as specified in the allotment memo through any of the Head Post Offices in Kerala or by way of Online Payment on any date from the evening of **03.02.2022 to 07.02.2022** and should join the course/college allotted from 04.02.2022 to 07.02.2022, 4.00 pm.

The list of Post Offices having facility for fee payment is available in the website.

As the fee for 2021-22 academic year is not yet fixed in three of the Self Financing colleges, namely Travancore Medical college Kollam, Believers Church Medical college Thiruvalla and P.K.Das Institute of Medical Science Palakkad, those candidates who get allotment in these colleges should provisionally pay the fee fixed for 2020-21 academic year and also submit an affidavit that they will pay the balance fee in case the fee to be fixed by the Admission Supervisory Committee/Government/Hon'ble High Court for the academic year 2021-22 is going to be higher than that of 2020-21 for these colleges.

NRI quota candidates for whom memos are pending for clearance in their 'Candidate Portal' as per the directions of Admission Supervisory Committee in order No. ASC 100/21/MBBS/BDS/NRI dtd.30.11.2021 have to clear the defects within the time limit specified in the said order ie, within a month time from the date of allotment by the Commissioner for Entrance Examinations or two days prior to the second allotment by the Commissioner for Entrance Examinations whichever is earlier, by uploading relevant documents for clearing the Memo. Those candidates who fail to upload the documents as specified within the time limit fixed by ASC will lose the allotment, if any, received under NRI quota in this phase and the NRI quota claim of the candidate will also stand cancelled. Any allotment received in NRI quota by such candidates in this phase will be treated as provisional.

The schedule of second phase of the Centralised allotment process to MBBS/BDS courses will be published later. Facility for **online option confirmation** and for rearranging the existing options/deleting the unwanted options will be provided before the second phase allotment.

**Note:** Those candidates who do not join the college allotted within the stipulated time (including candidates eligible for fee concession) will lose their allotment as well as all the existing higher options in the stream to which the allotment belongs.
