ADMISSION TO PG MEDICAL COURSES-2022

FIRST PHASE CENTRALISED ALLOTMENT LIST PUBLISHED

The first phase of Centralised allotment to PG Medical Courses for the academic year 2022-23 to the Government Medical Colleges in the State, Regional Cancer Centre (RCC), Thiruvananthapuram and Private Self Financing medical colleges is published in the website www.cee.kerala.gov.in. The allotment is based on the rank in the Kerala State merit list published by Commissioner for Entrance Examinations and online options filed by the candidates. The allotment to service quota seats is not included in this phase of allotment as the finalised service quota rank list has not been published. The allotment list is available in the website of the Commissioner for Entrance Examinations www.cee.kerala.gov.in. The final category list except for PwD quota is also published in the website. The final category list for PwD quota will be published in due course.

The Allotment Result and Allotment Memo will be available in the Candidate portal from **07.10.2022**. To view the allotment result, candidates should log on the 'PG Medical 2022-Candidate portal' by submitting their Application Number and Password. Then by clicking on the link 'Allotment Result', candidates can view their allotment result. It is necessary to take a printout of the Allotment Memo.

The allotted candidates should report for joining at the allotted colleges from **10.10.2022 to 13.10.2022 , 3.00 PM** along with the required documents specified in the Allotment Memo and Prospectus. The candidates shall decide the date of admission within the above schedule in prior consultation with the allotted College. The fee, should be remitted at the allotted college during admission. The fee shown for the courses in Self financing Colleges is as fixed by Admission Supervisory Committee/Govt. for the academic year 2021-22 and candidates are liable to pay the fee at the revised rate as and when the fee for the academic year 2022-23 is fixed by Admission Supervisory Committee/Government.

The allotted candidates who do not take admission in the respective college before

the time specified will lose their present allotment as well as all the higher order options and will not be considered for Second phase allotment. Also a candidate who vacates the seat joined in phase 1 will not be considered for phase 2 allotment. His/her options will be deleted and will only be able to participate in the Mop up round wherein fresh options are registered. Candidates shall refer the Prospectus for further guidelines on Centralised Allotment Process.

All the college authorities should approve the list of admitted candidates through Online Admission Management System (OAMS) at **4.00 PM on 13.10.2022**.

Note: Candidates who have claimed SC/ST reservation and whose caste status is under scrutiny by KIRTADS have been provisionally included in the category list and provisionally considered for allotment. The allotment/admission, if any, of such candidates shall be purely provisional and subject to final verification of their caste status. Also those candidates who had uploaded sworn affidavit stating that they will submit valid visa/online acknowledgment copy received at the time of submitting application for visa renewal on or before the last date fixed by the CEE for option confirmation to the second phase allotment to PGM-22, have been provisionally considered for the NRI category and allotment to NRI quota seats. Their allotment/admission in NRI quota seats if any will be cancelled if they fail to submit the document as prescribed within the stipulated time and will not be considered for NRI seats in further allotments.
