**FIRST ALLOTMENT**  
**PROVISIONAL ALLOTMENT LIST PUBLISHED**

The Provisional allotment list for first phase of Centralised allotment to PG Medical Courses for the academic year 2022-23 to the Government Medical Colleges in the State, Regional Cancer Centre (RCC), Thiruvananthapuram and Private Self Financing medical colleges is published in the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). The allotment is based on the rank in the Kerala State merit list published by Commissioner for Entrance Examinations and online options registered by candidates from 25.09.2022 to 01.10.2022. The online options registered by candidates whose results have been withheld and of those candidates who have been disqualified based on the Kerala State Merit list have not been considered for allotment. The provisional allotment list is available in the website of the Commissioner for Entrance Examinations [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in).

Final allotment will be published after addressing the complaints if any and the schedule of final allotment and joining will be published subsequently.

**Note:** Candidates who have claimed SC/ST reservation and whose caste status is under scrutiny by KIRTADS have been provisionally considered for allotment. The allotment/admission, if any, of such candidates shall be purely provisional and subject to final verification of their caste status. Also those candidates who have uploaded sworn affidavit of sponsor in case of memo for defect rectification in visa validity expired/expiring for NRI claim,

have been included provisionally for first phase allotment. Their Allotment/admission in NRI quota seats if any will be cancelled if they failed to submit the document as prescribed within the stipulated time and will not be considered for NRI seats in further allotment.

The fee of Self-financing medical colleges is as fixed by ASC/Govt. for the academic year 2021-22 and is subject to change and the candidate is liable to pay fee at the revised rate as and when fixed by ASC/Govt. for the academic year 2022-23.

Candidates are informed that the provisional result is indicative in nature and is subject to change.
