ORDER

As per the Government Order read as 2nd paper above, Government have issued orders fixing the fee structure for Post Graduate Medical (MD/MS/Diploma) courses during 2013-2014 in the Self Financing Medical colleges under the Kerala Private Medical College Management Association.

As per Clause 9 of the Postgraduate Medical Education Regulations, 2000 of Medical Council India, in non-Governmental institutions fifty percent of the total seats shall be filled by the competent authority and the remaining fifty per cent by the management of the institution on the basis of merit. In the circumstances sanction is accorded to the Commissioner for Entrance Examinations to allot 50% of seats in All Self Financing Medical Colleges conducting Post Graduate Medical Courses including the Colleges under Kerala Christian Professional College Managements' Federation and Academy of Medical Sciences, Pariyaram, for admission to Post Graduate Medical (MD/MS/Diploma) courses during 2013-2014 as per the seat distribution matrix prepared by the Director of Medical Education as per the methodology fixed vide Government Order read as 1st paper above. The fee structure for the Government Merit Quota seats of the Post Graduate Medical Courses in all institutions in the State for the

admissions for 2013-14 will be as specified below, subject to the final orders of the Hon'ble High Court in WP(C)No.9515 of 2012.

1. Post Graduate Degree (Clinical) - ₹ 6,00,000/-
2. Post Graduate Degree (Non-Clinical) - ₹ 2,40,000/-
3. Post Graduate Diploma (Clinical) - ₹ 4,50,000/-




