ADMISSION TO MBBS/BDS COURSES-2021 MOP UP ALLOTMENT LIST PUBLISHED

Mop up allotment to fill up the vacant seats in MBBS/BDS courses after the 2nd phase Centralized allotment has been published in the website www.cee.kerala.gov.in. The Mop up allotment list has been published on the basis of the online options registered by the candidates from 27.03.2022 to 31.03.2022, 10.00 AM, and as per the guidelines mentioned in the notification published by the Commissioner for Entrance Examinations on 26.03.2022.

The allotment memo will be available in the 'Candidate Portal' from **05.04.2022** evening onwards. The details of Mop Up allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. are available in the home page of the candidate and also in the Allotment Memo.

Candidates who receive an allotment afresh through the Mop up allotment should remit the fees/balance fee (if applicable) to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo by way of Online Payment or through any of the Head Post Offices in Kerala (List of Post offices is available in the website) from **05.04.2022** evening onwards. Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sree Chitra home, Juvenile home, Nirbhaya are eligible for fee concession. However if they are allotted under Minority/NRI quota seats in Self-financing Medical/Dental colleges, they will have to remit the full fee prescribed and they will not be eligible for any fee concession also.

Candidates who get an allotment through the Mop up allotment should join to the colleges concerned from 06.04.2022 to 08.04.2022, 2.00 PM. Candidates who get an allotment can download the 'Data Sheet' containing the basic details of the candidates by clicking the menu item 'Data Sheet' available in the home page of the candidate. The printout of the Data Sheet, Allotment Memo and other required documents mentioned in Prospectus clause 11.7.1 are to be produced before the college authorities at the time of

admission. No change in MBBS/BDS courses will be permitted after the Mop up allotment at any instance.

If the candidates who have already been admitted to MBBS/BDS course through previous allotments conducted by Commissioner for Entrance Examinations, get an allotment through Mop up allotment, their previous allotment will stand cancelled. The registration fee of those candidates who do not join to the course within the stipulated time after getting an allotment through Mop up allotment and of those candidates who lapse the seats after joining the course, will be considered as penalty. Penalty will also be applicable to those candidates, who lapse the MBBS/BDS seats after the Mop up allotment, as per KEAM 2021 Prospectus clause 12.2.4 (c)(ii).

If any stray vacancy exist in MBBS/BDS course after the Mop up allotment, will be filled up through Stray Vacancy filling as per the guidelines issued by the Commissioner for Entrance Examinations. Those candidates who are already admitted in MBBS/BDS course through previous allotment or those candidates who allotted through Mop up allotment will not be considered for Stray Vacancy allotment. The Details of Stray Vacancy allotment will be published later.
