### **ADMISSION TO THE PG MEDICAL(DEGREE/DIPLOMA) COURSES-2018 MINORITY QUOTA SEATS IN PRIVATE-SELF FINANCING MEDICAL COLLEGES DOCUMENTS TO PROVE MINORITY COMMUNITY INVITED FROM STUDENTS**

Candidates who seek admission under Minority quota seats in **Dr. Somervell Memorial C.S.I Medical College & Hospital, Karakonam, Thiruvananthapuram** shall have to login to the home page of the candidate through the link “**PG Medical 2018-Candidate Portal**” provided in the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) and should click the menu item ‘**Minority Quota**’ available therein. In addition, Proforma of the Community Criteria to be submitted in respect of each community category will be available for download against the community concerned. Candidates seeking admission under Minority Quota should obtain the Community Certificate in this prescribed format from the Community Office bearer and should produce the Community Certificate in original along with the filled up proforma containing the candidate details for verification in person at the office of the **Commissioner for Entrance Examinations on 04.05.2018, 2 pm.** Candidates who do not furnish the required documents for verification on the above date shall not be included in the minority list.

As per the notification of this office even No. dated 28.04.2018, candidates who wish to seek admission under Minority quota seats in the Private Self-financing Medical Colleges in the State having Minority status shall have to produce the Minority/Community Certificate in original along with the filled up Proforma containing the candidate details for verification in person at the **office of the Commissioner for Entrance Examinations on 04.05.2018, 2 pm.**

Community Certificate issued by the authority designated to issue the certificates alone shall be considered. Defective and incomplete Certificates shall not be considered. Candidates should ensure the Community Certificates are signed by the Authority concerned and proper seal is affixed in it. After verification of the Minority documents, final minority category list will be published in the website of Commissioner for Entrance Examinations.
