The first allotment to Kerala Ayurveda/Homoeopathy/Siddha/Unani /Agriculture/ Veterinary/Forestry/Fisheries/ Co-Operation & Banking/ Climate change & Environmental Science/B. Tech Biotechnology courses for the academic year 2021-22 has been published in the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in).

The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category allotted, Fee details etc. will be available in the Home Page of the candidates. The candidates should take a printout of the Allotment Memo. Those candidates who get allotment can download the 'Data Sheet' from 13.02.2022 by clicking the menu item 'Data Sheet' available in the Home Page. The printout of the Data Sheet, Allotment Memo and the documents as per clause 11.7.1 should be produced before the college authorities at the time of admission. The candidates can take admission in the allotted colleges from **14.2.2022 to 17.2.2022, 2.00 PM .**

Fee details of Medical & Medical Allied courses is available in the website. Those candidates who get allotment to Government /Aided colleges should pay the entire tuition fee to the Commissioner for Entrance Examinations. Those candidates who get

allotment to Self-financing colleges should pay the fee mentioned in the allotment memo to the Commissioner for Entrance Examinations. Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sree Chitra home, Juvenile home, Nirbhaya home will be exempted from payment of fee. However they will have to remit a token fee of Rs.1000/- to the Commissioner for Entrance Examinations.

Candidates should remit the fee payable to the Commissioner for Entrance Examinations, at any of the Head Post Offices in Kerala or by way of Online Payment on any date from 13.2.2022 to 17.2.2022. The list of Post Offices having facility for fee payment is available in the website. After remitting the Fee/Balance Fee (if applicable), the candidates should join the course/college allotted from 14.2.2022 to 17.02.2022, 2.00 PM.

**Note**

Those candidates who do not join the college allotted within the stipulated time (including candidates eligible for fee concession) will lose their allotment as well as all the existing higher options in the stream to which the allotment belongs.
