NOTIFICATION ENTRANCE EXAMINATION FOR ADMISSION TO THREE YEAR LLB COURSE 2022 APPLICATIONS INVITED

Applications are invited for the Computer Based Entrance Examination for Admission to **Three Year LLB Course 2022-23** in the four Government Law Colleges in Kerala and in the Private Self-financing Law Colleges in Kerala having seat sharing agreement with the State Government.

1. Eligibility for Admission

i. **Nativity**:- Applicant should be an Indian Citizen. However only those candidates who are of Kerala origin are eligible for any type of reservation or any of fee concession. [See clause 6(i) of the Prospectus].

ii. Academic Qualifications:-

- a. Candidate should be a graduate in any faculty of any University in Kerala or any other Universities, recognized by the particular University in Kerala to which the college that the candidate desire to get admitted is affiliated, as equivalent there to. (See Prospectus clause 6(ii)).
- b. A candidate who has passed the Bachelor's Degree examination with a minimum of 45% marks in aggregate (i.e., 45% marks for all the parts of the Degree Examination taken together) shall alone be eligible for admission to the Three year LLB course. However, candidates belonging to the Socially and Educationally Backward Classes need only 42% marks and those belonging to the Scheduled Castes/Scheduled Tribes need only 40% marks in the qualifying examination. No rounding off of percentage of marks to the nearest higher integer is permitted. Applicants who have obtained first degree certificate after prosecuting studies in distance or correspondence method shall also be considered as eligible for admission. The applicants who have obtained graduation/post-graduation through open universities system directly without having any basic qualification for prosecuting such studies are not eligible for admission.
- c. Candidates who are appearing/ appeared for the qualifying examination (regular examination of 2021-22 academic year) are also eligible to apply for the Entrance Examination. Such candidates become eligible for admission only if they produce the Provisional/Degree Certificate and Mark List of all parts the qualifying examination at the time of

admission.


- iii. Age: There is no lower age limit for admission to the Three year LLB course. The upper age limit for admission to the Three year LLB Course will be subject to the decision of the Hon'ble Supreme Court of India. In case the age restriction under clause 28 of Legal Education Rules, 2008 of Bar Council of India is reinstated, only those candidates within the stipulated age limit will be allowed to appear for the Entrance Examination.
- 2. Entrance Examination:- The Computer Based Entrance Examination will be conducted at selected centres in Kerala. The date and time of the Entrance Examination will be notified later. The questions will be based on General English, General Knowledge Arithmetic & Mental ability and Aptitude for Legal Studies. The Entrance Examination will be of two hours duration and will consist of 200 objective type questions of three marks each [Total: 200 x 3 =600]. For every wrong answer one mark each will be deducted.
- 3. Qualifying Standards in the Entrance Examination: To qualify in the Entrance Examination, and thereby figure in the rank list, a General/SEBC category applicant should secure a minimum of 10% of the total marks in the Entrance Examination whereas a candidate belonging to SC/ST category should get a minimum of 5% of the total marks.
- 4. Submission of Online Application and Application Fee:- The application fee is Rs. 685/-(Rupees six hundred and Eighty five only) for General and SEBC candidates and Rs. 345/-(Rupees three hundred and forty five only) for SC/ST candidates. Candidates seeking admission to the course can apply online through the website www.cee.kerala.gov.in of the Commissioner for Entrance Examinations from 27.07.2022 to 05.08.2022, 05:00 PM and should remit the required application fee within the date by way of online payment or by way of e-challan available during the submission of online application [see clause 13.2.3]. Net Banking/Debit Card/Credit Card facility can be used for Online Payment. Payment through e-challan can be made in cash at any of the Head Post Offices in Kerala. After fee payment, candidates should upload documents to prove Nationality, Date of birth, recent passport size colour photograph and scanned image of his/her signature within the above mentioned date. All other required documents/certificates as mentioned in clause 13.2.4 of the prospectus can be uploaded to the online application till 09.08.2022, 03:00 PM provided all the steps of application submission upto payment of application fee and the uploading of photograph, signature and the mandatory documents are completed on or before 05.08.2022, 05:00 PM. There is no need to send the printout of the application or any supporting documents to the office of the Commissioner for Entrance Examinations.
- 5. Certificates/Documents to be uploaded in the Online Application (in PDF format from 10 kb to 500 kb)
- Proof for Nationality and Nativity as mentioned. (See Prospectus clause 6(i)).
- Certificate to prove age: Relevant page of SSLC/Birth Certificate/Passport
- Non-Creamy Layer Certificate (for State Education purpose) from the Village Officer in the case of SEBC/OEC candidates.(Annexure XI)
- Community Certificate from the Village Officer in the case of OEC candidates who do not come under Non-Creamy layer category.(Annexure XV)

- Non-Creamy Layer Certificates/Community Certificates/ Income Certificates from the Village officer in the case of candidates belonging to the communities listed in Annexure IV (b).
- Community Certificate obtained from Tahsildar in the case of SC/ST candidates, also refer Prospectus Clause 9c (iii), Annexure XII.
- Inter-Caste marriage certificate: Candidates who are children of Inter-Caste married couple of whom one is SC/ST, need to upload Inter-Caste marriage Certificate issued by Tahsildar (See Prospectus Clause 9c (i)).
- The candidates eligible for EWS Quota seats should submit the EWS Certificate from the Village Officer in the prescribed format Annexure IX (a), IX (b) of Three Year LLB Prospectus.
- Certificate in support of special reservation, if any, in the prescribed format, (See Prospectus clause 11).
- Certificate from the District Medical Board for Persons with Disabilities (if applicable) (See Prospectus clause 9(e).
- Certificate from the Fisheries Officer concerned of Kerala Fishermen Welfare Fund Board for fee concession in the case of candidates who are the children of registered Fishermen.(Annexure XIV)
- Certificate from the Director, Department of Women & Child Development or from authorities concerned for fee concession in case of candidates who are inmates of Sri Chithra Home, Nirbhaya Home, Juvenile Home or any other such institution run by the Government.
- 6. Candidates will not be allowed to include any additional information in the application form or to submit any certificate / document claiming reservation or any benefits, after the submission of the online application.
- 7. Certificates, in the prescribed format, uploaded along with the online application alone will be accepted for claiming reservation or fee concession. Candidates eligible for various reservation fee concession can submit ecertificates issued by the Revenue Officers concerned. *In applicable cases, candidates can submit the e- certificates issued through Digilocker by organizations who are authorized partners of Digilocker, using the Digilocker requestor interface provided in the upload section of the online application.*
- 8. Admit Card:- Candidates registered for the Entrance Examination can download their Admit Cards from the website www.cee.kerala.gov.in, the date of issue of admit card will be notified later. Admit card should be brought to the examination along with valid ID proof.
- 9. **Allotment of Seats**:- Allotment will be made by the Commissioner for Entrance Examinations in accordance with the ranks obtained by the candidates in the Entrance Examination and the order of preference of institutions (options) registered by the candidates during online Centralised Allotment Process (CAP) (see Prospectus clause 15 for more information). The details of CAP will be notified in the website of the Commissioner for Entrance Examinations and in leading newspapers. Individual intimation in this regard will not be sent to the candidates.

The Computer Based Entrance Examination and subsequent allotments will be based on the provisions laid down in the Prospectus for Admission to Three Year LL.B Course 2022-23 available in the website www.cee.kerala.gov.in Candidates are
