**ADMISSION TO MBBS COURSE -2021**  
**SECOND ROUND STRAY VACANCY ALLOTMENT**

Vacancy existing in MBBS course in two Self-financing Medical colleges for the academic year 2021-22 as shown below, after the First round Stray vacancy allotment will be filled through Second round Stray Vacancy allotment. The Second round Stray vacancy allotment list to fill up the vacancy existing after First round Stray vacancy allotment has been published in the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). The allotment list has been published on the basis of the online options registered by the candidates during the MBBS/BDS Mop up allotment. Those candidates who are admitted in MBBS/BDS courses through All India allotment and those candidates who are presently admitted in MBBS/BDS course through the allotment conducted by Commissioner for Entrance Examinations and those candidates who got allotment through MBBS/BDS Mop up allotment and those who got allotment in MBBS course through first round Stray vacancy allotment have not been considered for Second round Stray Vacancy allotment.

The details of allotment of the allotted candidates will be available in the Home Page. Those candidates who get an allotment should take the printout of the Allotment Memo from the Home Page before 2.00 PM on 20.04.2022. The details of allotment such as **Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details** etc. will be available in the Allotment Memo.

Candidates who receive an allotment through Second round Stray Vacancy allotment should remit the fees/balance fee (if applicable) to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo by way of Online Payment or through any of the Head Post Offices in Kerala (List of Post offices is available in the website) and should join the colleges concerned on or before **20.04.2022, 2.00 PM** with required documents mentioned in Prospectus clause 11.7.1.

Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS)

25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sree Chitra Home, Juvenile Home, Nirbhaya are eligible for fee concession. However if they are allotted under Minority/NRI quota seats in Self-financing Medical college, they will have to remit the full fee prescribed and they will not be eligible for any fee concession also.

Candidates who get an allotment can download the 'Data Sheet' containing the basic details of the candidates by clicking the menu item '**Data Sheet**' available in the home page of the candidate. The printout of the Data Sheet, Allotment Memo are to be produced before the college authorities at the time of admission.

The registration fee of those candidates who do not join MBBS course within the stipulated time after getting an allotment through Second round Stray Vacancy allotment and of those candidates who lapse the seats after joining the course, will be considered as penalty and will not be refunded . Penalty will also be applicable to these candidates, who lapse the MBBS seats allotted through Second round Stray Vacancy allotment, as per KEAM 2021 Prospectus clause 12.2.4 (c)(ii).
