**THIRD PHASE ALLOTMENT TO ENGINEERING/ PHARMACY COURSES AND SECOND PHASE
ALLOTMENT TO ARCHITECTURE COURSES PUBLISHED**

The Third phase of allotment to Engineering/ Pharmacy Courses and the second phase allotment to Architecture courses-2020 is published in the website www.cee.kerala.gov.in. This is the last phase of allotment conducted by Commissioner for Entrance Examinations to Self Financing Engineering/Architecture/Pharmacy colleges. In this phase, allotment has been done to the 5 Self Financing Pharmacy colleges, Civil Engineering course in Palakkad Government Engineering college and Computer Science (Data science) in Mar Athanasius college, Kothamangalam.

Those candidates who have got an allotment in this phase should join to the concerned colleges from 11.11.2020 to 13.11.2020, 4.00 pm. The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available on the home page of the candidate as well as in the Allotment Memo. The candidates should take a printout of the allotment memo from the Home Page.

Candidates who receive an allotment in this phase should remit the fees to be paid to the Commissioner for Entrance Examinations (if applicable) as specified in the allotment memo at any of the **Head Post Offices in Kerala** or by way of **Online Payment** on any date from **10.11.2020 to 13.11.2020** and should join the course/college allotted before **4 pm on 13.11.2020**. The list of Post Offices having facility for fee payment is available in the website.

The instructions for admission to Government Engineering colleges, prepared by the Director of Technical Education is available in the website of Commissioner for Entrance Examinations. Those candidates who do not remit the fee/balance fee (if applicable) and who do not join the course/college allotted within the stipulated time will lose their allotment as well as all the existing higher options in the stream to which the allotment belongs.

Candidates who have got an allotment can download the 'Data Sheet' containing the basic details of the candidates by clicking the menu item '**Data Sheet**' available in the home page of the candidate. The printout of this Data Sheet, this phase allotment memo, and other documents (as per prospectus clause 11.7.1) are to be produced before the college authorities at the time of admission.

Important:

- 1) For the candidates who get an allotment through this phase to the Private Self Financing Engineering/Pharmacy colleges and who do not join colleges before the stipulated time, the conditions as per prospectus clause 12.2.4 (c)(i) shall be applicable for filing/retaining unnecessary options.

- 2) For the candidates who get an allotment through this phase to the Private Self Financing Architecture colleges and who do not join colleges before the stipulated time the conditions as per prospectus clause 12.2.4 (c)(ii) shall be applicable for filing/retaining unnecessary options.
- 3) Candidates admitted to the Private Self Financing Engineering/Architecture/Pharmacy colleges after this phase of allotment shall not be considered in the further allotments conducted by the Commissioner for Entrance Examinations to Engineering/Architecture/Pharmacy courses as per the relevant Government orders.

The notifications regarding further allotment to Engineering/Architecture/Pharmacy courses conducted by the Commissioner for Entrance Examinations will be published in the website later.
