ORDER

Government have been examining the question of having a separate set up for the conduct of entrance examination for professional courses in the State. In 1981-82 admission to the following courses were made after conducting the entrance examination.

- 3. B.H.M.S (Govt. Homeopathic Medical College, Calicut)

The Director of the Institute of Management in Government conducted the above examinations as per Government Orders.

2. For the year 1982-83 Government decided to conduct entrance examination for admission to the Engg. Colleges and this job was also given to the Director, Institute of Management in Government. Decisions have been taken for making admissions to Professional Colleges under the Health, Technical Education and Agriculture Depts. in the State in future after conducting entrance examinations for this purpose. Thus every year entrance examinations are to be conducted for admission to the following courses in the State.

3. At present the entrance examinations are being conducted by the Director of the Institute of the Management in Government by Special Government Orders for each Examinations. The Director of the Institute of Management in Government in the correspondence read above has stated that the conduct of entrance Examination by the Institute of Management in Government may not be proper since it may affect the work of the Institute. She has suggested the setting up of a separate infrastructure for conducting entrance examination for all the professional Courses in the State each year on regular basis.

- Government have examined the matter in all its aspects and are pleased to create a new set up and to appoint a Commissioner for Entrance Examination for the purpose of conducting entrance Examination for admission to Professional Colleges in the State from 1983 onwards. Shri.A.K.N. Nambiar who is now Commissioner for Educational Development and Research is appointed as the Commissioner for Entrance Examination in addition to his existing duties and responsibilities. He will be invested with adequate financial and administrative powers. Shri.A.K.N.Nambiar will forward necessary further proposals in the matter.
- 5. The Higher Education Department in the Secretariat will function as the administrative department in charge of the Commissionerate for Entrance Examination
